## WHERE DOES MY OFFERING GO?



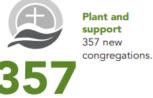
ELCA members in more than 9,300 congregations in the United States and Caribbean give approximately **\$1.75 billion** in regular offering to support ELCA ministries in their local communities and worldwide. When members give through their **congregations**, a percentage of that money is then shared with the local **synod** and the national **churchwide organization**.

This unrestricted giving, called Mission Support, gives us both the foundation and the fuel to do God's work in the world and a portion of the gifts circle back to support ministries in synods and local congregations. Of these unrestricted gifts, the churchwide organization receives around 2.6 percent. This represents the largest portion of the ELCA churchwide organization's operating budget.

About Eastern ND Synod:

Our Mission: "Jesus Christ calls us to live in love as we serve, equip, and challenge God's people."

The Eastern ND Synod is part of Region 3 of the Evangelical Lutheran Church in America.

The word "synod" comes from the Greek words: "syn-" meaning together, and "hodos-" meaning the way. A synod is a group of people on the way together.

The Eastern ND Synod is comprised of over 200 rostered leaders and over 101,000 baptized members. The synod covers approximately the eastern third of the state of North Dakota, and is divided into eight (8) conferences:

### Where does your Offering go?

More than 90% of all offering given is used to support its local congregation

ministries, leaders, and expenses. Less than 10% of those offerings are passed on to the synod and, from those gifts, the synod passes 41.5% to the churchwide organization/and some of that comes back to support synod ministries.

### Companion Synod: Central African Republic

Companion synod relationships of the ELCA connect Lutheran churches throughout the world with ELCA synods and congregations. These relationships are concrete expressions of the communion and fellowship with the more than 140 Lutheran member churches of the Lutheran World Federa-

tion. Each of the 65 synods has at least one international church companion and many have additional relationships, resulting in more than 120 companion synod relationships.

This is the promise we commit to as Women of the ELCA and as I report for the year 2022 you will see that our commitment extends to ministry, action, healing and wholeness in our church, our community, and our world.

As the year 2022 began we started to see the recovery of the pandemic of Covid that we have all had to deal with. It has been a slow process as we began to trust the environment that we live in, but with our trust and faith in our God we made an endeavor to proceed forth.

In January we had our election of officers and started set the budget for 2022. Officers elected where the same as the previous year:

With the donation we received from the Endowment Fund (\$500), we were able to move our two storerooms and reorganize. We purchased shelving for what is now known as the 'Casa de Fe Rummage Sale" room and the "WELCA Lutheran World Relief" room. Woody and Rose Wendt assembled all the new shelving, and the move took place. The shelving was \$429, and we gifted Woody \$75 for his help.

We took part in the Giving Hearts Day in February by donating to \$2100 to several of our benefactors which at that time is double through the Giving Hearts Foundation.

During the month of March, we worked on Lenten Soup and Sandwich Suppers along with the youth serving as part of their "service projects

In April we made our yearly appeal for items for health kits that would in turn be sent to LWR. The congregation was very generous with these donations. We inventoried our good silverware and purchased additional forks. We also made an appeal to people to save postage stamps and OUR FAMILY bar codes and to place them in the canisters at the back of the sanctuary. The labels bring us 5 cents per code. You snip the labels, we will do the counting and mailing, the funds go where needed at time of arrival...

May brought us some concern in meeting our budget but after much thought and consideration we decided we would have a bake sale in the month of June to help in our mission to meet our selected benevolent gifts. May is also the month where LWR items are taken to Fargo for distribution.

We did not have a meeting in June

In July we held our Crazy Day Walking Taco event uptown and started with the summer activity know as Thursdays on Central. These events are our major fund raisers for each year, and all did well regardless of heat or rain. We could use more help for these events so if you would like to be a helper, please let us know and we will call upon you... usually it is just a two-hour commitment and it is FUN. We had been working on new "Funeral Group' lists for several month and in July we finished and published our new lists. We have four working groups and one group of members who have given much help for many years and now they are Thank You Members. Each group has a chairperson and a co-chairperson. These groups are called in rotation for funeral or church wide potlucks. Moving into August, September, and October WELCA was busy getting ready for all the fall events as convention, fall festival and school kits. Dates are decided and plans are made. October is also another trip to Fargo with LWR kits.

November brings in the fall festival and this event involves many many people in our entire congregation. Once again, we had a fabulous turn out and much help. We also help with the Community Thanksgiving Baskets during this month.

One last little note summing up the entire year. WELCA takes time on several occasions, (Valentines, Mother's Day, Easter, Father's Day, Halloween, Thanksgiving and Christmas) to remember many of TLC's Shut-ins and Home Bound Members.

As the year comes to an end, we give much thanks for all the support the congregation gives to us and invite new participants in any area you may be interested in. We can always use hands on in the kitchen, shoppers, drivers and especially Thrivent Action Team participants. Please let us know if you're interested in knowing more about those teams or being part of any of our hospitality groups.
